Copy of Touch N Go statement indicating account name, details, parking entry and exit*	All Claims
Driver’s license & NRIC. (required for Parking and Toll Road accidents)	Parking and Toll Road claims
Incident report from the train/bus operator confirming the loss	Public Transport incidents
Police report and findings on the alleged accident (where applicable)	All Claims

\* In the event you are unable to provide the Touch N Go statement due to LPR system, Free Parking, Parking with Grace Period or Season Parking where the Touch ‘n Go card is used as an access tag, in a Car Park as defined under the Policy, you must provide evidence of parking from the relevant parking management.

Damage to Tyres	✓ Original receipts of tire repairing or replacing cost
